

Dear Valued Charitable Partner,

We are delighted to work with you in support of your organization's upcoming fundraising event.

Enclosed are seven (7) Resort Accommodation Certificates. The total value of our donation is approximately \$25,000. Each Certificate's value ranges from \$2,100 - \$3,800 based on resort, season, and number of rooms booked. You may use this in-kind donation for all types of fundraising at no cost to your organization.

Important: Each enclosed Certificate provides resort accommodations for 7 nights for up to two or three rooms, depending on the resort (the number of rooms is specified on each Certificate). All the winner has to pay for is their transportation and their food and beverage, which is covered by the required All-Inclusive supplement. As a condition of using these Certificates for your fundraiser, we kindly ask that you display the enclosed flyers and/or explain the terms of use. Keeping your fundraising event participants fully informed goes a long way towards maintaining their valued support of your organization and ours. Also, please be sure to advise your Certificate Winners, to validate and register their Certificate number and email address, after your event is completed. Rules of Usage: Each Certificate provides accommodations for up to two or three rooms (as specified on the Certificate) and is subject to a required nightly all-inclusive supplement of \$145 - \$300 per person, based on double occupancy, depending on the resort selected and travel dates. The Certificate All-Inclusive supplement covers dining (breakfast, lunch, dinner and snacks), unlimited beverages by the glass (including alcohol), and resort activities including non-motorized watersports. Government taxes/service charges are additional. The required supplement and taxes/service charges are collected by our office. At the time of booking, a deposit of \$600 per room is collected, remaining balance is due 30 days prior to arrival unless otherwise advised.

Note: Posting our Certificates online for "resale" purposes shall immediately invalidate these Certificates. Certificates can be transferred from the prize winner to a family member or friend however, they may not be advertised or "re-sold" online at eBay, Amazon, Craigslist or other similar sites.

Reservations: To redeem their Certificate and book their vacation, winners may call at (866) 611-5081 or email us at certificates@eliteislandresorts.com. Accommodations are subject to availability, so we recommend booking early for peak travel periods. Additional surcharge may apply seasonally and during Christmas week and February. All travel must be booked by the "Expiration Date" on each Certificate. Extension of Certificates may be granted beyond the "Expiration Date" at a fee of \$100. All Certificates are subject to prevailing rates at the time of booking.

Air Transportation is not included. We can assist the winners with air travel plans as we have access to airline fares and availability.
